Stallion Service Contract

for

Donnermeyer

(De Niro - Weltmeyer - Romadour II)

This agreement is made _____ (Date), between the stallion owner, Brookstone Farms, LLC, and the mare owner, _____. They agree to breed the mare, _____, registered with _____ (registry and number), to the Swedish Warmblood stallion, Donnermeyer, during the 2017 Breeding season. Mare owner agrees to the following fees:

1. Nonrefundable booking fee of \$200.00 USD, due with the signing of this contract.
2. A service fee of \$800.00 USD, which is the balance of the stud fee, is due prior to semen being shipped.
3. A collection and container fee of \$250 USD is due prior to each shipment of cooled semen. Mare owner agrees to provide a FedEx account number, or a valid credit card, to pay FedEx directly for shipping. We only use FedEx, so we can provide the best possible service. FedEx can provide a pre-estimate for all shipments.

Donnermeyer is a registered Swedish Warmblood stallion, approved for breeding with the American Warmblood Society (AWS). It is the mare owner's responsibility to verify the foal's eligibility for registration, with all registries (other registries may, and have, accepted Donnermeyer foals) and to fulfill the requirements of that registry. Brookstone Farms, LLC agrees to provide mare owner with a Breeding Certificate, as proof of this breeding.

Brookstone Farms, LLC offers a Live Foal Guarantee (LFG); should the mare not deliver a live foal, as a result of this breeding, the mare may be re-bred the following year with no additional stud fee (collection, shipping & container fees still apply), as long as Donnermeyer is still under Brookstone Farm's care and custody. In order for the mare owner to take advantage of the LFG, they agree to notify Brookstone Farms, LLC within 10 days of discovery, and provide written proof of the fact by a licensed veterinarian. If mare owner wishes to use another mare as a substitute, in the case of breeding unsoundness or the death of their mare, they may do so with the stallion owner's approval.

Mare owner understands that it is their responsibility to ensure mare is breeding sound, including obtaining a clean culture prior to breeding, to insure success. Mare owner also agrees to give mare proper care during her pregnancy, to insure a healthy foal, including; vaccinating with Rhinopneumonitis (Pneumabort) at 5, 7, & 9 months of her pregnancy, implementing an acceptable deworming schedule, feeding a proper diet (vitamins & 12% - 14% protein for last trimester), and keeping the mare current on her regular vaccinations (EWT, Flu & WNV). If this is not done, and the mare fails to produce a live foal, the Live Foal Guarantee is null and void.
